#### **ORDINANCE NO. 02-15**

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CORUNNA, MICHIGAN, CHAPTER 50 – OFFENSES AND MISCELLANEOUS PROVISIONS, ARTICLE II. OFFENSES AGAINST PROPERTY, BY ADDING SECTION 50-49. PROWLING/UNLAWFUL PRESENCE.

#### THE CITY OF CORUNNA, MICHIGAN ORDAINS:

SECTION I. ADDITION OF SECTION 50-49. PROWLING/UNLAWFUL PRESENCE, OF THE CITY CODE OF THE CITY OF CORUNNA, MICHIGAN, shall be as follows:

## Section 50-49. Prowling/Unlawful Presence.

- a. <u>Prowling In Alleys, On Private Property</u>. It shall be unlawful for any person to prowl about any alley or the private premises of any other person in the nighttime, without authority or the permission of the owner of such premises. A person who violates this section is guilty of a misdemeanor punishable by imprisonment for not more than 90 days, or a fine of not more than \$500.00, or both.
- b. <u>Unlawful Presence</u>. It shall be unlawful for any person to lurk, lie in wait or be concealed in any building or any yard or premises within the city, with intent to do any mischief or to pilfer or to commit any crime or offense whatever. A person who violates this section is guilty of a misdemeanor punishable by imprisonment for not more than 90 days, or a fine of not more than \$500.00, or both.

## SECTION 2. Severability.

This Ordinance and the several sections, sub-sections, paragraphs, clauses and parts thereof are hereby declared to be severable. If any part or clause thereof is declared or adjudged invalid by present or future legislation or decree, the balance of the Ordinance shall not be affected thereby.

# SECTION 3. Conflicting Ordinances Repealed.

All Ordinances previously adopted and incorporated in the Code of the City of Corunna, Michigan, through codification procedures, or any existing Ordinances that are inconsistent with the provision of this Ordinance are hereby repealed, and in the case of inconsistencies, to the extent of such inconsistency, are hereby repealed.

## SECTION 4. Copies Available.

This Ordinance may be purchased or inspected in the City Clerk's Offices, Monday through Friday, between the hours of 9:00 a.m. and 4:30 p.m.

#### SECTION 5. Effective Date.
