

ORDINANCE NO. 03-01

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CORUNNA BY AMENDING CHAPTER 74 – TRAFFIC AND VEHICLES, ARTICLE II. – UNIFORM TRAFFIC CODE, TO AMEND SECTIONS 74-56, ADOPTION AND 74-57, REFERENCES IN CODE, WHICH IS THE ADOPTION BY REFERENCE OF THE: UNIFORM TRAFFIC CODE FOR CITIES, TOWNSHIPS, AND VILLAGES, TO ADD SECTION 74-59, PENALTIES, AND TO PROVIDE FOR ENFORCEMENT AND PENALTIES FOR VIOLATIONS THEREOF.

I. AMENDMENTS TO CORUNNA CITY CODE, ARTICLE II. UNIFORM TRAFFIC CODE, OF CHAPTER 74, shall be as follows:

Sec. 74-56. Adoption.

~~The Uniform Traffic Code for Cities, Townships, and Villages promulgated by the commissioner of state police and published in the 1979 edition of the Michigan Administrative Code and amendments as published in the Quarterly Supplement No. 5 to the 1979 edition of the Michigan Administrative Code, in accordance with Act No. 62 of the Public Acts of Michigan of 1956 (MCL 257.951 et seq.), as amended, is hereby adopted by reference as modified in this article.~~ **The Uniform Traffic Code for Cities, Townships, and Villages as promulgated by the director of the Michigan Department of State Police pursuant to the Administrative Procedures Act of 1969, 1969 PA 306, MCL 24.201 to 24.328 and made effective October 30, 2002, and all future amendments and revisions to the Uniform Traffic Code when they are promulgated and effective in this state are incorporated and adopted by reference.**

Sec. 74-57. References in code.

References in the Uniform Traffic Code for ~~Michigan~~ Cities, Townships and Villages to ~~the term a~~ “governmental unit” shall mean the ~~city~~ **City of Corunna**.

Sec. 74-59. Penalties.

The penalties provided by the Uniform Traffic Code for Cities, Townships, and Villages are adopted by reference.

II. NOTICE TO BE PUBLISHED AND COPY AVAILABILITY.

The city clerk shall publish this ordinance in the manner required by law and shall publish, at the same time, a notice stating the purpose of the Uniform Traffic Code for Cities, Townships, and Villages and the fact that a complete copy of the code is available to the public at the office of the clerk for inspection.

III. CONFLICTING ORDINANCES AND PORTIONS THEREOF REPEALED.

All Ordinances previously adopted and inconsistent with the provisions of this Ordinance are repealed, and in the case of inconsistencies, to the extent of such inconsistency, are hereby repealed.

IV. EFFECTIVE DATE.

This Ordinance shall take effect pursuant to the Corunna City Charter, immediately upon publication hereof.
