

ORDINANCE NO. 10-01

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CORUNNA, MICHIGAN, CHAPTER 2 – ADMINISTRATION, ARTICLE IV. BOARDS AND COMMISSIONS, DIVISION 6. PARKS & RECREATION COMMISSION, BY AMENDING SECTION 2-242. MEMBERSHIP THEREOF, AND ALSO TO AMEND DIVISION 4. SOFTBALL COMMISSION, BY AMENDING SECTION 2-207. MEMBERSHIP THEREOF.

THE CITY OF CORUNNA, MICHIGAN ORDAINS:

SECTION I. AMENDMENT TO SECTION 2-242. MEMBERSHIP, OF THE CITY CODE OF THE CITY OF CORUNNA, MICHIGAN, shall be as follows:

Sec. 2-242. Membership.

The parks and recreation commission heretofore established is continued.

- (1) The commission shall consist of nine **or eleven** administrative officers appointed in accordance with section 4.7 (administrative service) of the City Charter for indefinite terms serving at the pleasure of the council.
- (2) Of the commission membership there will be a president, vice-president, treasurer and secretary voted upon by the entire commission. All meetings must have five **or six** members present **relative to the nine or eleven membership** to enact business.
- (3) All members of the parks and recreation commission shall serve as such without compensation. The ~~nine person~~ commission membership shall not include a city councilperson or the mayor. ~~A majority of the membership shall be comprised of residents or real property owners of the City of Corunna.~~
- (4) Proposed minutes of the parks and recreation commission meetings are to be submitted to the city manager within ten business days following the parks and recreation commission meeting. Approved minutes are to be submitted to the city manager within five days of approval.
- (5) Any commissioner absent two consecutive meetings or 25 percent of regular meetings in a calendar year, without prior written approval by the city manager, will be considered for removal from the commission. All absences shall be recorded in the meeting minutes.
- (6) Upon recommendation of the city manager, the city council may appoint one ex officio member to the commission. The ex officio members so appointed by the city council shall not have a vote at the meetings, but shall sit only in an advisory capacity.
- (7) All administrative officers shall be responsible to the city manager in and for the performance of the duties of their office.

SECTION II. AMENDMENT TO SECTION 2-207. MEMBERSHIP, OF THE CITY CODE OF THE CITY OF CORUNNA, MICHIGAN, shall be as follows:

Sec. 2-207. Membership.

The softball commission heretofore established is continued.

- (1) The commission shall consist of ~~seven~~ **nine** or ~~nine~~ **eleven** administrative officers appointed in accordance with section 4.7 (administrative service) of the City Charter for indefinite terms serving at the pleasure of the council.
- (2) ~~The softball commission shall elect from its membership a president, vice president, treasurer and secretary. All meetings must have four or five members present relative to the seven or nine membership to enact business.~~ **Of the commission membership there will be a president, vice-president, treasurer and secretary voted upon by the entire commission. All meetings must have five or six members present relative to the nine or eleven membership to enact business.**
- (3) All members of the softball commission shall serve as such without compensation. The ~~seven or nine person~~ commission membership shall not include a city councilperson or the mayor. ~~A majority of the membership shall be comprised of residents or real property owners of the City of Corunna.~~
- (4) Proposed minutes of the softball commission meetings are to be submitted to the city manager within ten business days following the softball commission meeting. Approved minutes are to be submitted to the city manager within five days of approval.
- (5) Any commissioner absent two consecutive meetings or 25 percent of regular meetings in a calendar year, without prior written approval by the city manager, will be considered for removal from the commission. All absences shall be recorded in the meeting minutes.
- (6) Upon recommendation of the city manager, the city council may appoint one ex officio member to the commission. The ex officio members so appointed by the city council shall not have a vote at the meetings, but shall sit only in an advisory capacity.
- (7) All administrative officers shall be responsible to the city manager in and for the performance of the duties of their office.

SECTION 2. SEVERABILITY.

This Ordinance and the several sections, sub-sections, paragraphs, clauses and parts thereof are hereby declared to be severable. If any part or clause thereof is declared or adjudged invalid by present or future legislation or decree, the balance of the Ordinance shall not be affected thereby.

SECTION 3. CONFLICTING ORDINANCES REPEALED.

All Ordinances previously adopted and incorporated in the Code of the City of Corunna, Michigan, through codification procedures, or any existing Ordinances that are inconsistent with the provision of this Ordinance are hereby repealed, and in the case of inconsistencies, to the extent of such inconsistency, are hereby repealed.

SECTION 4. COPIES AVAILABLE.

This Ordinance may be purchased or inspected in the City Clerk's Offices, Monday through Friday, between the hours of 9:00 a.m. and 4:30 p.m.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall take effect pursuant to the Corunna City Charter, immediately upon publication hereof.
