RULES AND REGULATIONS FOR TREE PLANTINGS, REPLACEMENTS, REMOVALS, AS WELL AS PLANTS AND SHRUBS WITHIN THE CITY OF CORUNNA PUBLIC RIGHT-OF-WAYS OR PUBLIC PARKS.

All tree plantings, replacements, or removal of trees, plants, and shrubs within the boundaries of the City of Corunna right-of-ways, parks, and public grounds of the city and lands within the control of the city shall be regulated by the City of Corunna Forestry Commission as set forth in the City of Corunna Ordinance #82 - Sections 82-31 thru 66.

1. Any property owner within the City of Corunna limits who wishes to plant a new tree, remove or replace a current tree, place plants or shrubs that exceed a mature height of 12” within the street or alley right-of-ways, parks and or public grounds and upon lands within the control of the city must fill out and submit the attached application to the Forestry Commission. The Forestry Commission at their next scheduled meeting shall review the application along with recommendations from the Superintendent of the Department of Public Works and the Chief of Police and either deny or grant with possible conditions the right of the property owner to do any of the above. The Forestry Commission may at their discretion seek and offer compromises to the applicant to allow for the protection and maintenance of public safety and right-of-way improvements.
2. The property owner is responsible for all planting, maintenance, and watering, of any new planting and is also responsible for the total removal of such tree or that part of the tree that is not healthy and proposes a risk to the health and safety of the public. The Forestry Commission or their designated city official may set forth any necessary requirements needed as well as a time frame in which to fulfill the above requirements. Any requirements set forth by the Forestry Commission not fulfilled by the property owner may be taken care of by the Forestry Commission or their designee and all expenses charged against the property owner. Any new tree planted must have a main trunk diameter of at least 2 – 2 ½ inches.

APPROVED TREES BY FORESTRY COMMISSION* (Subject to review by the Forestry Commission)

*Absence of a tree not listed on the approved tree list does not necessarily mean a tree is not permitted but rather, more precise review is needed by the Forestry Commission for acceptance or denial.
