RESIDENTIAL REFUSE DISPOSAL OPTION DECLARATION FORM

The City of Corunna Curbside Refuse Pickup Service is provided by Priority Waste. **Regular City of Corunna Curbside Refuse pick-up will be weekly on Mondays.** If a Federal Holiday falls on a weekday, garbage collection will be delayed by one day. See reverse side for the list of Holidays that fall on weekdays this year.

City Curbside Refuse Pickup Service will be billed to you quarterly on your City of Corunna water/sewer utility bill.

The Refuse Management Ordinance of the City of Corunna requires the proper removal and disposal of solid waste materials. The ordinance also provides eligible property owners with their choice of several refuse disposal options.

A summary of service requirements is printed on the reverse side of this form.

Note: Rental units, that are not owner-occupied, are eligible for option 1 only.

City Curbside Refuse Pickup Service

1) **Weekly Curbside Cart Service**

\$13.65 per month (\$40.95 per quarter) – 95-gallon cart with unlimited extra bags for the duration of this contract, to include three (3) bulk-items per week and bi-weekly curbside recycling.*

2) **Weekly Curbside Cart Service**

\$13.65 per month (\$40.95 per quarter) – 65-gallon cart with unlimited extra bags for the duration of this contract, to include three (3) bulk-items per week and bi-weekly curbside recycling.*

Curbside Opt-Out/Bag Tag Service (Option available for non-rental owner-occupied properties that were opted out by June 15, 2022.)

3) **Private Contract Backdoor Service of Owner Transport**

I am opting out of the City Curbside Refuse Pickup service and will be responsible for disposal of my refuse in accordance with the provisions, rules and regulations of the Refuse Management Ordinance of the City of Corunna, to include mandatory weekly service.

Refuse Management Ordinance General Requirements

On October 1st, 2007, the Corunna City Council approved Ordinance 07-02, "An Ordinance to Amend Chapter 62 Solid Waste of the Code of Ordinances of the City of Corunna "To Require Mandatory Residential Refuse Pickup"". The ordinance provides for a city-wide residential curbside refuse collection program, while at the same time allowing eligible property owners a choice to "Opt-Out" of the curbside service. This page provides a summary of ordinance requirements, rules and regulations.

Every owner, occupant or person in possession of real or personal property in the City of Corunna are subject to the requirements of the Refuse Management Ordinance and any rules promulgated there under as approved by the Corunna City Council. Refuse shall not be allowed to accumulate and shall be properly disposed of within the city.

Violations: Failure to provide a signed option declaration form, unauthorized use of the City Curbside Refuse Pickup, or failure to comply with the provisions of the ordinance, rules, and regulations shall result in automatic and involuntary assignment to cart service for the duration of the city-wide contract.

Holidays on Weekdays: New Years, Memorial Day, Independence Day, Thanksgiving, Labor Day, and Christmas

City Curbside Refuse Pickup Specific Requirements

Residents are asked to use maximum 30-gallon trash bags, durable enough to be lifted by the top of bag without tearing.

Containers and Dumpsters: Priority Waste shall provide one (1) ninety-five (95) gallon cart or one (1) sixty-five (65) gallon cart to each residential dwelling for the provision of all normal household solid waste placed curbside for collection on Mondays. **Priority Waste** shall also provide one (1) ninety-five (95) gallon cart or one (1) sixty-five (65) gallon cart to each residential dwelling for the provision of all normal household recyclable placed curbside for collection bi-weekly on Mondays. All refuse/trash/garbage must be placed in 30-gallon bags in the provided cart. Should the resident have more garbage than will fit in the cart, residents are permitted to place extra bagged garbage next to the cart for collection at no extra charge. Extra bagged garbage shall only be placed beside the curbside cart the morning of collection.

Collection: Containers shall be placed reasonably close to the street, if possible next to driveway, no later than 7 a.m. each Monday and no earlier than 7 p.m. on Sunday. After collection, containers must be removed promptly away from the street, but no later than 7p.m. on the day of collection. Collection days and times of refuse service may be modified by the Corunna City Council and holiday conflicts. If a federal holiday falls on a Monday, garbage collection will be postponed until Tuesday. **If garbage was set out in time for pick-up, but was missed, call Corunna City Hall at (989) 743-3650 x1 as soon as possible.**

(* Rates: Current rates (\$13.65 a month) are guaranteed from July 1, 2023 through June 30, 2024.

Eligible participants in the City Curbside Refuse Pickup will have two (2) options as follows:

95/65 Gallon Cart Service: With the Cart Service, participants will be provided a 95-gallon or 65-gallon poly cart. Priority will take unlimited extra bags outside of this cart. These extra bags must be either placed beside the cart the day of pickup or in an additional container if placed out the night before pickup. Service will be billed on the City of Corunna Utility Bill.

Bulk Items: Priority Waste will provide bulk item collection to all Cart customers. Each homeowner is allowed three (3) bulk items per week to be picked up for free along with their regular garbage pick-up. The bulk item cannot be more than 4 feet in length or weigh over 50 pounds. Private Backdoor Refuse Pickup (Opt-Out) Specific Requirements

This option is available for non-rental owner-occupied properties only that were opted out by June 15, 2022.

Eligible property owners (owner occupants) may opt-out of the City Curbside Refuse Pickup service in favor of Private Backdoor Refuse Pickup. Weekly residential refuse pickup is mandatory. Any such property owners will be responsible for disposal of their refuse in accordance with the provisions, rules and regulations of the Refuse Management Ordinance of the City of Corunna. Persons opting-out may opt-in at any time. Property owners must provide proof of back door service along with a declaration form signed on file at Corunna City Hall to be in compliance. Failure to comply with the provisions of the ordinance, rules, and regulations shall result in automatic and involuntary assignment to cart service for the duration of the city-wide contract.

Collection: Containers for opt-out service shall be kept and serviced as near to the back entrance of the premises as is reasonably possible, except that they may be kept next to an alley provided they are shielded from view of any street by shrubbery and/or other screening. Any containers shall be emptied at least once a week. Containers, bags, and bulk items shall not be placed next to any street. Collection days and times of refuse service may be established by the Corunna City Council, and may not occur on days scheduled for City Curbside pickup.

Rates & Service Options: Participants in the Opt-Out Program are responsible to negotiate their own service rates, payment terms, and service level with their provider. Service shall be for back door pickup only. Again, weekly service is mandatory.
